Online voting and voting by mail will begin at 9AM AST on Friday, October 22, 2021 and will end at 8PM AST on Friday, November 5, 2021. In-person voting will take place at the NEC office on Friday, November 5 from 9AM to 6Pm AKST. The election results will tentatively be announced on Saturday, November 6, 2021 at the NEC annual membership meeting.
