- 4. **A digital photo of yourself.** Please send a high-resolution digital head-and-shoulders photo for use in the candidate profiles document that will be sent to voters and posted on the election website.
- 5. **A short bio of yourself.** It should be 125-150 words long and will be used in the candidate profiles document. This could include verbiage from your letter of intent.
