**Purpose of Position**

Under direct supervision of the Housing Specialist and Executive Director, responsible for the carpentry, construction and repairs of the NEC Housing Program renovation projects.

Uphold the organization’s mission, and corporate values as well as demonstrate understanding of and compliance with organization’s policies and procedures.

**Essential Functions**

- Must maintain a safe work environment proactively with weekly safety meetings and monitor work environment for safety issues and immediately correct them.
- Ensure any work performed on housing projects conform to applicable National, State, and/or local Building Codes.
- Provide project description, prepare blueprints and sketches using hand and computer-generated drawings as needed; for Projects, Environmental Reviews, and Building Permits.
- Provide oversight to projects as needed, assist with the coordination of projects with contractors and sub-contractors for additional components of the projects.
- Request quotes, develop materials lists for projects and coordinate materials orders for approval by the housing specialist.
- Provide project progress through project work schedule, daily logs and photographs.
- Responsible for the framing of structures, including foundations, floors, walls, roofs, stairways and interior partitions.
- Responsible for the installation of siding, roofing, flooring, windows, doors, cabinetry, weather stripping, plumbing and electrical fixtures, and interior and exterior trim.
- Assists with development and maintenance of inventories of materials, supplies, tools and equipment.
- Prepare and oversee: layout and assembly of project materials; shaping of materials to prescribed measurements; assembly of cut and shaped materials.
- Other duties as assigned

**Personal Traits:**

Employees of Nome Eskimo Community are expected to promote the organization’s mission and vision. Employees are expected to demonstrate integrity, professionalism, accountability, cooperation with and consideration of others.

## Knowledge and Skills

All employees are expected to have general knowledge of Alaskan Native culture, traditions, history, and needs as well as customer service skills and the ability to manage their time and organize their work to ensure efficient performance. In addition, all employees should have a general knowledge of computers, copies, fax machines, and typical software, the ability to follow policy, procedure, instruction, communicate regularly with their supervisors, and the ability to understand and manage confidentiality.

Specific knowledge, skills and abilities required for position:

- Knowledge of National, State, and/or local Building Codes.
- Knowledge of OSHA Laws and Requirements
- Knowledge of Alaska “Cold-Weather Climate Building” techniques.
- Must be dependable, self-motivated, and work with minimum supervision.
- Skill in oral and written communication, skill in establishing and maintaining cooperative working relationships with others
- Ability to manage multiple priorities

## Minimum Qualifications

- **Education:** Certification in Carpentry or a related field is required. Progressively responsible professional work experience may be substituted on a year for year basis for degree requirement.
- **Experience:** Must have at least 4 years comparable work experience or demonstrated proficiency at NEC.

## Additional Requirements or Credentials:

- Must have a valid Alaska Driver’s License

## Physical Requirements and Working Conditions:

- Must be able to lift at least 70 pounds
- Must be in good general health with the ability to be exposed to dust and fumes
- Use of hands and arms to operate tools and equipment
- Work is conducted in residential settings and a housing shop
- Stand and/or walk more than half the workday
- Bend, stretch, twist, crouch and/or reach
- Push or pull using up to moderate force
